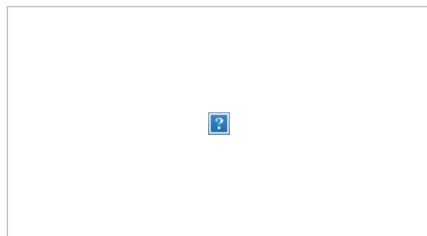
You will note from our more recent Schedule 5 submissions that we have incorporated reporting in accordance with OTNOC requirements.
