High half hourly CO results recorded from Line 2 (A3) during period 01 Oct - 31 Dec 2025 as follows;

528.31mg/m3 for period 09:30-09:59 on 26/10/2025

134.35mg/m3 for period 07:00-07:29 on 04/12/2025

657.31mg/m3 for period 09:30-09:59 on 17/12/2025

All cases high result due to issues with residual waste on grate. Consolidated as Category 4 breach for Q4 2025 in accordance with condition 3.1.2 (**E1 -Emissions - Air**) of the permit. Impact considered negligible on Air Quality Standard and as such a consolidated category 4 has been scored in line with EA guidance.

Schedule 5 submissions and this response will be placed on Public Register

Ongoing action to track progress of improvements specified in the sites strategic CO emissions review. Of note - the site are to apply to vary the permit to include a 10 minute average (95%ile) with a CO limit of 150mg/m3.
