Hi [REDACTED],

We've confirmed that the issue originated in the baghouse filters, as outlined in the Schedule 5. The investigation found that one of the filter bags had become detached due to an installation error. This detached bag was the likely cause of the elevated emissions.

Although it was limited to 1 bag out of 200, it still resulted in an elevated emission that required operational intervention. The issue was identified quickly on shift and the affected cell was boxed in and the unit load was reduced to minimise emissions and maintain compliance.

Can you confirm that this can be recorded as an Abnormal Operation based on the findings above?

Durham Filtration have also agreed to return and carry out a dye test on the other baghouse filters.
